Questions and Answers about Trona Valley Community FCU's Scholarship Program

- Q.** What type of scholarships does Trona Valley award?
- A.** Trona Valley is offering four \$2,000.00 scholarships this academic year to new high school graduates and/or continuing college students.
- Q.** How will the scholarship recipients be selected?
- A.** An impartial panel of judges will select four (4) scholarship winners based on their strengths in academics, accomplishments in and out of the classroom, and their desire to achieve their future goals.
- Q.** Do I have to be a member of Trona Valley Community Federal Credit Union to apply for a scholarship?
- A.** Yes, our scholarships are awarded only to Trona Valley members.
- Q.** How can I become a member of Trona Valley Community Federal Credit Union?
- A.** All you have to do is open an account! Trona Valley is a community credit union, which means anyone who lives, works, worships or attends school in Sweetwater, Uinta, Lincoln or Sublette County can join. You are also eligible to join if you have family members who belong to the credit union.
- Q.** What can the scholarship money be used for?
- A.** Scholarship money can be used for any college expenses including books, tuition, and living expenses.
- Q.** How do I apply for a scholarship?
- A.** To apply, you need to write a letter of intent, outlining your past achievements and academic goals. You also need to complete the Trona Valley Scholarship Application, and provide us with a current transcript.
- Q.** When is the application deadline?
- A.** Applications are accepted until the close of business on **June 30, 2011**.
